151750	INTIMATED SAMAR, CGAE KOCHI ABOUT THE INCIDENT AND DIRECTED TO BE STANDBY.
151810	CGAE KOCHI DIRECTED TO LAUNCH CGDO FOR IDENTIFICATION/INTERDICTION OF SUSPECT VESSEL AND SAMAR DIVERTED TO PROCEED WITH BEST SPEED TO AREA OF INCIDENT.
151910	MRCC (MB) ANALYSED AIS-SB PLOT AND CONFIRMED MV ENRICA LEXIE TO BE SUSPECT VESSEL IN POSN 235 KOCHI LT 48 NM COURSE 340 SPEED 14 KTS.
151930	INS KABRA SAILED OUT.
151935	CG DORNIER LAUNCHED FROM INS GARUDA AND ICGS LAKSHMIBAI DIRECTED TO SAIL WITH DISPATCH.
151950	04 COASTAL POLICE PERSONNEL REPORTED DHQ-4 FOR EMBARKING ONBOARD ICGS LAKSHMIBAI.
151950	CG DORNIER LOCATED MT ENRICA LEXIE IN POSN 09 ⁰ 51.6 N 075 ⁰ 37.5 E AND ADVISED VESSEL TO COME TO KOCHI ANCHORAGE AND SHADOWED THE VESSEL.
152000	LAKSHMIBAI SAILED OUT WITH 04 CSP PERSONNEL EMBARKED FOR INTERDICTION/BOARDING MT ENRICA LEXIE.
152130	INFORMED CPT FOR PROVIDING OUTER ANCHORAGE FOR MT ENRICA LEXIE.
152235	LAKSHMIBAI INTERCEPTED THE VESSEL AND ESCORTED TILL OUTER ANCHORAGE. THE VESSEL ANCHORED IN POSN 09 ⁰ 56.19 N 076 ⁰ 07.06 E (249 FAIRWAY BUOY 4.5 NM). LAKSHMIBAI MAINTAINED PATROL AROUND THE VESSEL.

160200	ICGS LAKSHMIBAI MAINTAINING PATROL IN AREA. STATE POLICE REQUESTED TO DEPUTE POLICE PERSONNEL FOR BOARDING VESSEL AM 16 FEB 12.
160910	36 POLICE PERSONNEL WITH 03 COMMANDOS HEADED BY ONE ACP EMBARKED ONBOARD LAKSHMIBAI OFF DHQ-4.
161045	BOARDING PARTY DISEMBARKED FROM L'BAI FOR MT ENRICA LEXIE.
161120	CG BOARDING PARTY ALONGWITH 35 POLICE PERSONNEL EMBARKED MV ENRICA LEXIE FOR INVESTIGATION/INTERROGATION OF SHIP'S CREW.

151732	FAX MESSAGE RECEIVED FROM DIST POLICE CHIEF, KOCHI CITY REGARDING MINISTRY OF EXTERNAL AFFAIRS DIRECTED TO DETAIN MT ENRICA LEXIE AND THE VESSEL SHOULD NOT BE PERMITTED TO LEAVE UNTIL FURTHER DIRECTION FROM GOVT. OF INDIA AND TO BE TAKEN INSIDE KOCHI PORT.
151810	CPT INTIMATED PERMISSION FOR BRINGING THE VESSEL INSIDE HARBOUR.
151921	FAX MESSAGE TO COMMISSIONER OF POLICE REGARDING CPT AGREED TO BERTH THE VESSEL INSIDE HARBOUR.
152030	LAKSHMIBAI ENTERED HARBOUR.
152235	MT ENRICA LEXIE WEIGHED ANCHOR AND COMMENCED ENTRY TO KOCHI HARBOUR.
152335	PILOT CPT BOARDED THE VESSEL OFF FAIRWAY BUOY.
170140	MV ENRICA LEXIE SECURED ALONGSIDE COT BERTH AT CPT.
170235	FAX MESSAGE SEND TO COMMISSIONER OF POLICE, KOCHI CITY REGARDING WITHDRAWAL OF CG BOARDING TEAM FROM MT ENRICA LEXIE.
171430	SAMAR ENTERED HARBOUR.
